

MONSOON FURY CONTINUES

26 villages of Sehore dist cut off from head quarters

Twenty six villages of Sehore district have been cut off from district head quarters due to heavy rain and flood like situation on Thursday. SDM Aditya Kumar Jain said, "Villages have been flooded because of swelling water level of Narmada River due to opening of sluice gates of various dams like Tawa, Barna and Kolar. Besides, there is heavy rainfall in the district. District administration have deployed its teams and having close vigil on situation."

Sehore district, Rehi recorded 145mm rainfall while Nasrullganj recorded 150mm rainfall and Budani recorded 126mm rainfall on

Thursday. Sehore city itself recorded 54mm rainfall. Hoshangabad recorded 161mm rainfall. The villages which are worst affected include Neelkand, Manjhali, Chhindgaon, Kachhi, Badgaon, Ambadid, Chameti, Dimawar, Mandi, Silkanth, Antaralia, Chaurasakhedhi, Sohankhedhi, Dhaulpur, Nimakhedi, Satdev, Tigali, Ranipura, Lordi, and Khadgaon. In addition to Narmada river, local rivers like Sip River, Ambad-Bambad also played havoc marooning villages like Sukarwasa, Magaria, Manjakhedhi, Chhap, Gorakhpur, Semalpani as their road connectivity has been disrupted from district headquarter. Monsoon rain of varied intensity has been lashing the state of Madhya Pradesh for

days together. The last 24 hours also saw good rains over many parts. Isolated pockets also saw some heavy rainfall activity, one such city was Hoshangabad. As per meteorological department, the axis of Monsoon Trough is over North Madhya Pradesh and neighbouring areas with the Low Pressure being over North Madhya Pradesh and adjoining South Uttar Pradesh. With this, more rains will continue to lash the state of Madhya Pradesh. However, rainfall activity will witness a reduction as compared to the past 24 hours. However, parts including Mandla, Hoshangabad, Betul, Seoni, Khandwa, and Khargone may see some rains which will continue until September 14.

Provisions of new Motor Vehicle Act are irrational: Nath

Rajput terms it Tughlaqi order

We want to stop road accidents and to save people's lives, but the provisions of new Motor Vehicle Act are irrational, tweeted the chief minister Kamal Nath, on Thursday. While the road transport minister Govind Singh Rajput termed it as a Tughlaqi order. Many states are not following the new MV Act and some of the states had slashed down to 50 per cent of the penalty through their discretion power.

In state MP till date the new Act is not imposed and the government is planning to put financial burden on citizens. CM stated that the penalty should be such that person can afford to pay it out, "Presently the country is experiencing huge recession, the Govt should rethink on its decision and should provide relief to the citizens." He further added that the government is conducting a study on the new Motor Vehicle Act. Rajput stated that the MV Act is a Tughlaqi order, most of the fines are more than what common men can afford, "I will discuss the matter with the CM and try to lessen the burden wherever required."

ACS opposes, cabinet disposes

The state cabinet has decided to create 15 temporary posts of additional director general of Police (ADGP).

A cabinet meeting held on Wednesday took the above decision. Nevertheless, Additional Chief Secretary (ACS) of the finance department, Anurag Jain, opposed the government decision.

Jain said since the promotion to the post of ACS is done only when senior officers are retired, there should not be any reason to create temporary posts for the IPS cadre. It should not have been done, he said.

In response to Jain's statement, Chief Minister Kamal Nath stuck to his guns saying the cabinet had taken the decision and it would not be changed.

The cabinet approved giving pay-scale as proposed by the Seventh Pay Commission to the professors

of medical colleges and those of the dental colleges across the state.

The cabinet approved pay-scale in the range of Rs 1,44,200 according to UGC to director, medical education, joint director, medical education and professors. Similarly, approval has been given for pay scale in the range of Rs 1,31,400 to associate professor and reader. Lecturer will be given pay scale of Rs 68,900 and demonstrator will be given pay scale of Rs 57,700.

MLAs' car loan limit proposal put off

The cabinet had to defer the proposal to raise car loan for MLAs from Rs 10 lakh to 15 lakh because of opposition from minister of general administration Govind Singh. According to the proposal the MLA concerned will pay 4% of interest on the loan and the government will take care of the rest of the loan. Singh said the state was facing financial problem such proposal cannot be approved. Apart from that, all the MLAs have luxury cars. Chief Minister has put off the decision following Singh's opposition.

They also went on a one-day strike in support of their demand.

They also warned the government of giving mass resignations. State government spokesman PC Sharma said doctors of medical colleges have been given seven pay scale but their service conditions will also be changed. According to Sharma, it would be ensured that they work full time during their duties.

The cabinet also gave its approval on implementing Safe City program in six cities of the state. The scheme, with a ratio of 60:40 of Central and State

contribution, is going to cover Bhopal, Indore, Gwalior, Jabalpur, Chhindwara and Chhatrapur. The scheme would be run through Nirbhaya Fund and its nodal department will be woman and child development department. A budget of Rs 5 crore has been fixed for the programme. Efforts will be made, in collaboration with other departments, to make cities full safe for women.

The cabinet also gave its approval on providing Rs 25,000 for entrepreneurship development to self-help groups in Dhar, Jabua and Alirajpur.


Water harvesting at PTC

Lawyers strike to protest construction of district court near Pipliyahana lake

Lawyers in Indore were on strike on Thursday against construction of District Court near Pipliyahana lake. Due to the strike as many as 8000 cases could not be heard and were given new dates, lawyers said.

The lawyers are arguing that the spot chosen for construction of the court building was once part of the Pipliyahana lake and against environmental norms.

The lawyers are pointing out that even during the construction phase there is water logging at the construction site, proving that the construction was taking

place on the lake's bed. The lawyers expressed fear that water-logging would continue even after the construction gets completed.

However, sources in the court said there was little chance of the project getting stalled as it had been cleared by the high court. Meanwhile, residents at Pipliyahana area too protested against the construction of the building to save the lake. On Thursday, the residents protested and raised slogans near the construction site. They demanded that the lake should be preserved and the court building should be shifted.
