

# Slight reduction in Chinese troops in Pangong Tso area

## But No Real Pullback Like In Galwan

**New Delhi:** There has been a slight further reduction in the number of Chinese troops in the Pangong Tso area of eastern Ladakh but no discernible pullback like in Galwan Valley and Gogra-Hot Springs, where 'buffer zones' have been created to prevent clashes between rival troops in the high-altitude region.

The initial withdrawal of Chinese soldiers from 'Finger-4' to 'Finger-5' area (mountainous spurs) on the north bank of Pangong Tso, if and when it happens, will signal the completion of Phase-I of the de-escalation plan finalised between the rival corps commanders on June 30.

Army has pulled down some tents, moved back a few vehicles and slightly reduced its troops at Finger-4 but not vacated the area. The troop confrontation at the lake (at an altitude of 13,900 feet), in fact, is proving to be the toughest to resolve with over 3,000 PLA soldiers occupying the 8-km stretch from Finger-4 to 8 sin-

ce early-May," said a source.

According to security sources aware of the situation, there was a meeting between local authorities in Ladakh. The discussions were attended by the Ladakh administration, Army and ITBP officers. The problematic issue, which India rejects, is the Chinese expectation that In-

dian troops also pull back in equal measure. This means India will move back further from the LAC as it sees it while China only retreats from an area it has intruded upon.

With India's perception of the Line of Actual Control running north to south at Finger-8, it wants PLA troops to pull back eastwards to their post at Finger-8 and permanent bases at Sirijap-I and II further beyond.

India has a post between Finger-2 and 3, along with an administrative base between Finger-3 and 4. But China, after building numerous fortifications and taking the heights from Finger-4 to 8, is claiming territory right up to Finger-2, from where it can threaten two crucial Indian roads. "PLA had agreed to pull back from Finger-4 to 5 under Phase-I. Negotiations between local commanders are underway. The corps commanders may meet again to discuss Pangong Tso," the source said.

# Armymen asked to delete FB, Insta a/cs and 80 apps

**New Delhi:** The 13-lakh strong Army has directed all its officers and soldiers to delete their Facebook and Instagram accounts as well as over 80 apps from their mobile phones by July 15.

Citing security considerations and leakage of sensitive data, the Army said those who do not follow the order will face strict action. The outlawed apps include the 59 with Chinese links, including TikTok, which were banned by the Union government recently.

"The directive has been issued because there has been an exponential increase in the

number of military personnel being targeted online by intelligence agencies of Pakistan and China," said an officer.

The Army in November last had directed its personnel to avoid the use of WhatsApp for official work, while asking officers holding "sensitive appointments" to delete their Facebook accounts.

There have been many cases over the last two-three years where Pakistani agents posing as women have "virtually" honey-trapped Indian military personnel into divulging classified information, with even a Group Captain posted at the Indian Air Force headquarters in New Delhi falling

prey to it in 2018.

The fresh Army directive, taken to ensure the security of classified information in the larger national interest, comes after the Indian Navy also banned the use of Facebook for all its personnel, while also directing them not to carry smart mobile phones into bases and dockyards as well as on board warships, in December last year.

The Navy had issued the directive after several sailors from Vizag, Karwar and Vizag and a Mumbai-based hawala operator were arrested for allegedly leaking information to Pakistan after being lured into online relationships.

## Disengagement in 3-4 points set to happen in Phase 2

As part from monitoring of recently created buffer zones, Indian forces will keep a close watch on the Chinese build-up along the LAC.

For the present, after both sides arrived at an agreement at the commanders' meeting on June 30, the Chinese side involved in the negotiations, was clearing out of areas covered by PPI4, PPI5 and PPI7A, where, at last count, five structures had been removed. On the northern bank of Pangong Tso, the Chinese have cleared out of three points on Finger 4, moved to Finger 5, but have held out on further disengagement on 3-4 points there until 'Phase 2' of the process.

# Terrorists enter BJP Bandipora chief's house, shoot him, dad & brother dead

**Srinagar/New Delhi:** The BJP's Bandipora district head Waseem Bari, his father and brother were shot dead in their north Kashmir house by terrorists late on Wednesday. This is being seen as the first major incident involving a senior political leader after Article 370 was nullified in 2019.

Waseem, (38), his father Sheikh Bashir Ahmad (62) and brother Umar Sheikh (30) were at their two-storeyed residence which houses a family-run restaurant barely 30 metres away from the police station — and 600 metres from the residences of the deputy commissioner and district police chief — when the incident happened.

"All three have firearm injuries in the head. There are injuries in other parts of the body as well. We have handed over the bodies to the police," a senior Bandipora medical official told TOI.

The family had been provided security

cover comprising eight personnel from the Jammu and Kashmir police's armed battalion. However, none of the the cops attached with Bari were present when the killings took place around 8.30pm.

Police sources said the eight cops are being placed under suspension with immediate effect and investigations are on to probe the reasons for their absence.

"We are trying to find why none of the eight cops were present. Further action is being discussed with the Bandipora police," said a top Jammu and Kashmir police officer.

Bari was routinely involved in the BJP's membership drive and had frequently been facilitating visits by Union ministers and top party leaders to the region.
